CHAPTER - I INTRODUCTION





INTRODUCTION:

- 1.1 Right to Information Act, 2005, provides for setting out the practical regime of right to information for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority.
- 1.2 It's a decade since the Act came into force and now would be the right time for all stakeholders to get together, identify the strengths and weaknesses, and suggest remedial measures, both administrative and legislative, for more effective implementation of the Act.
- 1.3 It is a matter of grave concern that the pendency in the Commission is increasing day by day mainly due to the failure of some First Appellate Authorities to dispose the appeals within the prescribed time limit. Most of the second appeals, filed before the Commission, are not against the orders passed by these authorities but on account of the their failure to pass any orders at all resulting in a very heavy case load on the Commission and consequent long waiting time for the appellants. Unless the Government, and the Public Authorities under it, act fast and take stringent action against the defaulting First Appellate Authorities the day may not be far off when the Commission will also become one more institution, with huge pendency, defeating the very purpose of the Act, namely, enabling the citizens to get information in a time bound manner.
- 1.4 In pursuance of the mandate under section 25(1) of the Act, the Commission is submitting this Annual Report to the Government containing an overview of the status of implementation of this Act during the year 2014-15.
- 1.5 This report contains analysis of data received from all the State Government departments in accordance with the responsibility cast upon them under sections 25(2) and 25(3) of the Act.
- 1.6 The report includes:
 - (i) Number of officers designated as PIOs and First Appellate Authorities.
 - (ii) Number of requests for information received and disposed by the Public Information Officers.
 - (iii) Number of appeals received and disposed by the First Appellate Authorities.
 - (iv) Number of complaints and second appeals received and disposed by the Commission.



- (v) Amount collected as initial fee and further fee collected by the Public Information Officers.
- (vi) Amount of penalty imposed on Public Information Officers and compensation awarded.
- (vii) Analysis of information furnished by departments.
- 1.7 Accounts of the Commission and Recommendations also form part of this report.

CHAPTER-III GENERAL INFORMATION

Introduction:

This chapter covers various activities of the Commission during the year. They are: Out-station hearing of cases by the Commission, Petitions heard through Video Conference; Compensation awarded to appellants, penalties imposed on PIOs, etc.

- 3.1 During 2014-15, 544754 requests for information were received from all parts of the State, seeking information from PIOs of various departments and other authorities under this legislation. Out of this, only 2.77% of the applicants approached the Commission in the form of 3,161 complaints Under Section 18(1) and 12,727 appeals Under Section 19(3) of the Act.
- 3.2 During the year, the Commission disposed of 10234 cases.

3.6 Compensation awarded by the Commission:

- 3.6.1 Under Section 19(8)(b) of the R.T.I. Act, Commission is empowered to direct the Public Authorities to compensate the appellants for the loss or other detriment suffered by them.

CHAPTER-IV IMPLEMENTATION OF THE RTI ACT






IMPLEMENTATION OF THE RTI ACT

- 4.1 The Right to Information Act, 2005, empowers the citizens of the country to seek information which is available in material form, from Public Authorities. After the enactment of the Act on 12th October 2005, section 22 of the Act came into force which has got over riding effect on provisions of the existing enactments which prevent disclosure of information; except the information exempted under sections 8, 9 and 10 of the Act.
- 4.2 Section 2(f) of the Act defines what is "information" and Section 2(j) defines what is "Right to Information". During the last 10 years, citizens are increasingly using RTI Act for getting information.

Statistical Analysis:


- 4.3 Though the Act was brought into force on 12th October, 2005, the response was poor initially. However, with increasing awareness, 6,18,429¹ requests were received in the state during the year.
- 4.4 Fig 1 below indicates the trend in use of RTI Act by the citizens in the State.





- 4.5 During the year, the number of requests for information received and disposed by all the Public Information Officers has gone up by 25.03% and 28.33% respectively.
- 4.6 Fig.2 below shows the details of the total number of Requests for information received and disposed by the PIOs and the First Appeals received and disposed by the First Appellate Authorities during the year 2014-15.




4.7 Fig. 2(a) below shows the percentage of First Appeals filed before the First Appellate Authorities as against requests for information filed before the Public Information Officers of Government departments in the State. This varies from 0.08% (Women & Child Dept.) to 12.91% (DP & AR Dept.).











- 4.8 As in the previous year, during this year also, *three departments* viz, Revenue Department received the highest number of requests for information (2,00,703) followed by RDPR: 1,00,772 and Urban Development Department: 84,384. The number disposed by these three departments is 1,94,109, 97,666 and 77,783 respectively. These three departments collectively accounted for 67.36% of the total requests received by all the Departments during the year.
- 4.9 Requests for information received by RDPR and Revenue Department saw an increase of 36.18% and 36.80% respectively. Urban Development Department witnessed a decrease of 5.21%
- 4.10 The other departments, which received requests in five digits, are Home(30,155) ,Transport (24,569), Education (23,527),Finance (16,356),Energy (14,806), Health, Family Welfare & Medical Education (14,133),Public Works Department & National Highway (13,085),



Commerce & Industries (10,940) together constituting 25.76% of the total requests received by all Departments.

4.11 The Act has provided **exemption from disclosure of information** as follows:


- Section 8(1) Notwithstanding, anything contained in this Act, there shall be no obligation to give any citizen:
- (a) information, disclosure of which would prejudicially affect the sovereignty and integrity of India, the security, strategic, scientific or economic interests of the State, relation with foreign State or lead to incitement of an offence;
- (b) information which has been expressly forbidden to be published by any court of law or tribunal or the disclosure of which may constitute contempt of court;
- (c) information, the disclosure of which would cause a breach of privilege of Parliament or the State Legislature;
- (d) information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party, unless the competent authority is satisfied that larger public interest warrants the disclosure of such information;
- (e) information available to a person in his fiduciary relationship, unless the competent authority is satisfied that the larger public interest warrants the disclosure of such information;
- (f) information received in confidence from foreign Government;
- (g) information, the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes;
- (h) information which would impede the process of investigation or apprehension or prosecution of offenders;
- (i) cabinet papers including records of deliberations of the Council of Ministers, Secretaries and other officers:
 - Provided that the decisions of Council of Ministers, the reasons thereof, and the material on the basis of which the decisions were taken shall be made public after the decision has been taken, and the matter is complete, or over:
 - Provided further that those matters which come under the exemptions specified in this section shall not be disclosed;
- (j) information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is



satisfied that the larger public interest justifies the disclosure of such information:


Provided that the information which cannot be denied to the Parliament or a State Legislature shall not be denied to any person.

- 4.12 The Supreme Court of India in its order in Civil Appeal No.7571 of 2011 dated: 2-9-2011, has clarified the provisions of Section 8(1) of the Act and held that sub-sections (a), (b), (c), (f), (g) and (h) are "Absolute exemptions"; (d), (e) and (j) as Conditional exemptions and (i) as "Specific period exemption".
- 4.13 Under Section 8(1) of the Act, the PIOs denied information in 2642 requests during the year. The details are shown in Fig. 2.2 below



4.14 Fig.2.3 below shows the details of requests pending with various Government departments as at the end of the year 2014-15. During the year, the total number of pending requests is 19,854 as against 28,095 in 2013-14. A total of 5932 requests were reported pending in Revenue Department, followed by Urban Development Department, (5,391). These two departments, put together, account for 57.03% of the total requests pending during the year. Total numbers of requests pending are 3.75% of the total requests received by all departments.






4.15 During the hearing of Appeals under section 19(3) of the Act, Commission observed that in some cases, first appeals under section 19(1), are neither heard nor disposed. Some authorities are simply adjourning the cases, much beyond the prescribed period, thereby forcing the Appellants to approach the Commission under section 19(3) of Act. Thus, such inaction of the First Appellate Authorities has not only created tremendous case load on the Commission but has also resulted in the applicants not getting the information within the stipulated period.



4.16 Fig. 2.4 shows the number of First Appeals reported to be pending with the First Appellate Authorities.











CHAPTER - V

IMPLEMENTATION OF SECTIONS 4(1)(a) AND 4(1)(b) OF THE ACT BY DEPARTMENTS DURING THE YEAR 2014-15

5.1 Section 4 of the Act mandates every Public Authority to discharge certain obligations which are as follows:

Section 4: Obligations of public authorities

- 4(1) Every public authority shall:
- 4(1)(a) maintain all its records duly catalogued and indexed in a manner and the form which facilitates the right to information under this Act and ensure that all records that are appropriate to be computerised are, within a reasonable time and subject to availability of resources, computerised and connected through a network all over the country on different systems so that access to such records is facilitated;
- 4(1)(b) publish within <u>one hundred and twenty days</u> from the enactment of this Act,-
 - (i) the particulars of its organisation, functions and duties;
 - (ii) the powers and duties of its officers and employees;
 - (iii) the procedure followed in the decision making process, including channels of supervision and accountability;
 - (iv) the norms set by it for the discharge of its functions;
 - (v) the rules, regulations, instructions, manuals and records, held by it or under its control or used by its employees for discharging its functions:
 - (vi) a statement of the categories of documents that are held by it or under its control;
 - (vii) the particulars of any arrangement that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof;
 - (viii) a statement of the boards, councils, committees and other bodies consisting of two or more persons constituted as its part or for the purpose of its advice, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public;
 - (ix) a directory of its officers and employees;
 - (x) the monthly remuneration received by each of its officers and employees, including the system of compensation as provided in its regulations;
 - (xi) the budget allocated to each of its agency, indicating the particulars of all plans, proposed expenditures and reports on disbursements made;



- (xii) the manner of execution of subsidy programmes, including the amounts allocated and the details of beneficiaries of such programmes;
- (xiii) particulars of recipients of concessions, permits or authorisations granted by it;
- (xiv) details in respect of the information, available to or held by it, reduced in an electronic form;
- (xv) the particulars of facilities available to citizens for obtaining information, including the working hours of a library or reading room, if maintained for public use;
- (xvi) the names, designations and other particulars of the Public Information Officers;
- (xvii) such other information as may be prescribed; and there after update these publications every year;
- 4(1)(c) publish all relevant facts while formulating important policies or announcing the decisions which affect public;
- 4(1)(d) provide reasons for its administrative or quasi-judicial decisions to affected persons.
- Sec 4(2) It shall be a constant endeavour of every public authority to take steps in accordance with the requirements of clause (b) of subsection (1) to provide as much information Suo-Motto to the public at regular intervals through various means of communications, including internet, so that the public have minimum resort to the use of this Act to obtain information.
- 5.2 In pursuance of the decision taken by the State High Level Committee in its meeting held on 19.05.2012, Circular bearing No.DPAR 44 RTI 2009, dated 13.08.2012, was issued constituting the following Committee to monitor and review the progress of implementation of Section 4 of the Act:

5.3 In Letter no:DPAR:64:RTI:2015, dated 23-05-2015 the Under Secretary, DPAR (Janaspandana), has informed that during the year the Committee has examined the implementation of section 4 of the RTI Act by the following departments:



- (1) Education Department
- (2) Rural Development and Panchayat Raj Department
- (3) Revenue Department
- (4) Home Department
- (5) Urban Development Department
- 5.4 During visits to districts the Commission has observed that many Public Authorities are yet to prepare and publish the catalogue of files under section 4(1) (a). Some Public Authorities have scanned the files, but the catalogue of files is yet to be prepared. Some other Public Authorities have prepared the catalogue of files but citizens cannot access it since it is not published on the website of the concerned Public Authority. The Commission has also observed that the information published by many public Authorities, under section 4(1) (b), is very perfunctory though there is a statutory obligation on them to provide as much information suo moto to the public at regular intervals.
- 5.5 The Commission suggests that the DPAR (Janaspandana) may request the concerned Administrative Department to prepare the list of all Public Authorities under its administrative control and indicate against each Public Authority the date of preparation of 4(1) (a) and 4(1) (b) information, the dates on which it has been revised and published on the website of the Public Authority. DPAR (Janaspandana) may then do a random test check of the information published on the website and place its comments before the committee. This will enable the committee to make a meaningful review and guide the departments, in effectively discharging the statutory obligations cast on the Public Authority, under section 4 of the RTI Act, both in letter and spirit.

CHAPTER - VII RECOMMENDATIONS





RECOMMENDATIONS:

7.1 The following recommendations, requiring amendment to the RTI Act, are proposed for consideration of the State Government and recommending to the Central Government.

7.2 Head of office to be deemed as PIOs on failure of the Public Authority to notify

Some Public Authorities have failed to notify the PIOs of field level offices making it difficult for the citizens to apply to the correct PIO and later approach the appropriate First Appellate Authority. In all such cases the Head of Office may be considered to be PIOs and the Head of the next higher office as First Appellate Authority.

7.3 Need to define fiduciary relationship mentioned in Sec 8(1) (e) of the Act

This needs to be done for the benefit of citizens seeking information, the PIOs and Appellate Authorities under the Act.

7.4 Applicants to provide details for invoking the life and liberty provision

Many applicants invoke the proviso to section 7 (1) for seeking information within 24 hours. Since no details are provided by the applicant, in justification of his request, it is difficult for the PIOs and Appellate Authorities to consider such requests. Hence it may be necessary to make mandatory for the appellant, seeking to invoke this provision, to provide sufficient justification in support of his request.

7.5 Successor PIO to be made liable for imposition of penalty for not providing the information within 30 days of taking charge

At present only the PIOs as on the date of request for information, can be penalized under section 20 (1) and recommended for disciplinary action under section 20(2) of the Act. Since the PIOs keep on changing, due to transfer, retirement etc., it is necessary that the succeeding PIOs should be made responsible for providing information, in all pending applications, within 30 days of taking charge failing which the provision of sec 20 (1) and section 20(2) could be invoked against them. The Act maybe amended accordingly.

7.6 To substitute the word "complainant" by the word "appellant" in section 19 of the RTI Act.

Since the section relates to appeals the word **"complainant**" in section 19 (8) (b) and section 19 (9) may be substituted by the word **"appellant"**



7.7 To delete the words "including any right of appeal" in section 19 (9) of the Act

Since the Act does not provide for any appeal against the orders of the Commission the words "including any right of appeal" may be deleted.

7.8 Insertion of new provision to provide for abatement of complaints/appeals

In the event of death of complainant or appellant, the complaint or appeal, as the case may be, shall stand abated.

7.9 To provide time limit for filing complaints

The period within which complaints, under section 18, are to be filed has not been stipulated as a result of which complaints are being filed, even after lapse of several years, leading to abuse of the process of the Commission.

7.10 To provide for second appeal to the Commission only against the order of the First Appellate Authority

Normally, under all laws, second appeal lies only against the order passed by the First Appellate Authority. Hence it should be made mandatory for the First Appellate Authority to pass orders within the prescribed time and also make a provision to enable the First Appellate Authority to enforce its order if the PIOs fails to comply within the time limit set by it.

7.11 Act to provide for vacancy in the Office of the Chief Information Commissioner

The Act may be amended to provide that when the office of the State Chief Information Commissioner or the Central Chief Information Commissioner, as the case may be, is vacant or a person occupying such office is, by reason of absence or otherwise, unable to perform the duties of his office, these shall be performed by the senior most Commissioner of the State Information Commission or the Central Information Commission, as the case may be.

7.12 To Substitute the word "Appeal" in the place of the word "review" in sub clause (e) of clause (ii) of section 10

The Act does not have any provision for review or revision. It provides only for appeals under section 19. Hence this amendment is proposed.
