KIC 1286 PTN 2009 KARNATAKA INFORMATION COMMISSION

(Sri Suresh Ramappa Barki vs. PIO, Directorate of Schedule Tribe Welfare, Bangalore)

ORDER

12-6-2009

- 1. Petitioner is absent. Respondent Sri Srinivas, PIO and Assistant Director, Directorate of Scheduled Tribe Welfare, Bangalore, represents the Respondent.
- 2. Petitioner in his request for information dated 14-12-2008 has sought the following information:
 - ತಮ್ಮ ಪತ್ರ ಸಂಖ್ಯೆ ಪವಕ:ಗಿಉಯೋ:ಸಿಆರ್ 01/2008-09 ದಿನಾಂಕ 1-7-2008ರ ಪ್ರಕಾರ ಪರಿಶಿಷ್ಟ ವರ್ಗದ ಉದ್ಯಮ ಶೀಲರಿಗೆ ಕೆ.ಎಸ್.ಎಫ್.ಸಿ. ನೀಡುವ ಸಾಲದ ಬಡ್ಡಿಯ ಶೇ. 4ರ ವ್ಯತ್ಯಾಸದ ಹಣವನ್ನು ಭರಿಸುವ ಬಗ್ಗೆ, Administrative orderನ ಒಂದು ಪ್ರತಿಯನ್ನು ದೃಢೀಕರಿಸಿ ಪೂರೈಸುವುದು.
- 3. As there was no response from the Respondent within the stipulated period of 30 days, the Petitioner filed a complaint to the Commission on 11-2-2009 under section 18(1) of the RTI Act.
- 4. Commission issued summons on 25-3-2009.
- 5. In response, the Respondent has filed his replies dated 12-6-2009 along with a copy of the Government order bearing no. 76 SLP 2008 dated 5-6-2009. Respondent states that the same matter was heard by the Commission in complaint no. KIC 8283 COM 2008 wherein the proposal was sent to the Government seeking the approval for providing the interest rates subsidy of 4% on loan taken by SC/ST entrepreneurs from KSFC and as the proposal was still under consideration, the Petitioner was accordingly intimated on 13-3-2009.
- 6. However, he states that since the Government order has been issued now, a copy of the same has been issued to the Petitioner on 12-6-2009 through RPAD. He has filed a report in this regard.
- 7. Commission noted the compliance.
- 8. However, the Commission noted undue delay in furnishing the information. Therefore, the Commission directs the Respondent to be cautious and prompt in dealing with the requests for information received under the RTI Act, 2005.
- 9. In view of the compliance and in terms of the direction, the complaint is disposed off as having been complied with.
