KIC 7386 PTN 2009 KARNATAKA INFORMATION COMMISSION

ORDER

- 1. Sri Pradeep, Advocate for Sri G. Papireddy and others, represents the Petitioner. He files vakalat. Respondent Sri Balachander, PIO and Executive Engineer, Solid Waste Management, No. 2 Division, BBMP, Dasappa Hospital Complex, Bangalore, is along with Sri Nagaraj Karanth, Audit Officer.
- 2. Petitioner in his request for information dated 10-6-2009 has sought the following information:

Kindly inform regarding action taken on the application dated 28-10-2008 to refer the dispute to the Commission, BBMP. If any action is already taken inform the applicant the full details of the action taken or order passed. If no action is taken, kindly inform the reason or reasons for not taking action on the application dated 28-10-2008.

- 3. However, the Petitioner filed a complaint to the Commission on 21-7-2009 under section 18(1) of the RTI Act stating that the Respondent has not furnished any information.
- 4. Commission issued summons on 8-10-2009.
- 5. In response, the Respondent has filed a copy of the intimation dated 23-6-2009 and 1-12-2009 addressed to the Petitioner along with a copy of the intimation dated 25-11-2009 addressed to the Petitioner. Further, Sri Balachander states that the information was again sent to the Petitioner on 25-11-2009 through RPAD.
- 6. However, the Petitioner's Advocate states that he has not received the communication. Respondent has handed over a copy of the intimation to the Petitioner's Advocate on the spot.
- 7. Since the Petitioner's Advocate insisted the certified copy, the Commission returned the original containing the signature of the Respondent filed to the Commission to the Respondent to hand over the same to the Petitioner's Advocate on the spot. Petitioner has returned the photocopy of the information which is taken on file.
- 8. The Advocate for Petitioner states that he has received the relevant information now.
- 9. In view of the compliance, the complaint is disposed off as having been complied with.
